During a meeting with the Regional Office, the program specialist and grantee specialist suggested that you revisit your community assessment data and connect with the local Growers Associations to determine if there are unserved agricultural working families.

8. After serving as the Head Start director for about nine months, Lorna received a call from the large grocery store chain where the agency bought most of its food for preparing meals. The store representative wanted to know why the agency had failed to pay invoices on its open purchase order system. They were in arrears by about \$8,000. After conducting research, Lorna found that all the purchase orders had been signed by the receptionist. This receptionist later admitted that she had been buying her family groceries using the agency purchase order system, and when invoices matching these purchase orders came in the mail, she intercepted them so that the fiscal office never received them.
