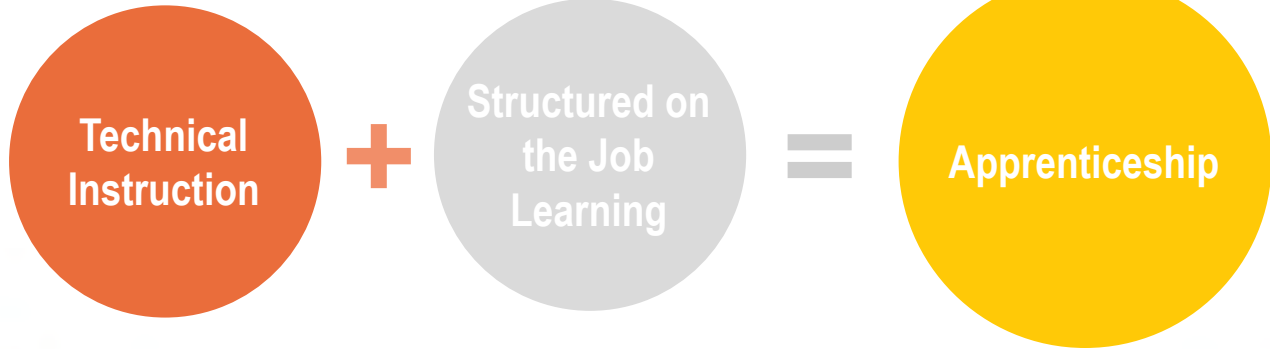


Seven Ss of Goal-Setting With Families

What is a Registered Apprenticeship Program?

- A Registered Apprenticeship Program (RAP) is a proven model of apprenticeship to help job seekers immediately start working and increase skills and earnings
- Validated by the Department of Labor or a State Apprenticeship Agency.
- Provide a nationally recognized credential

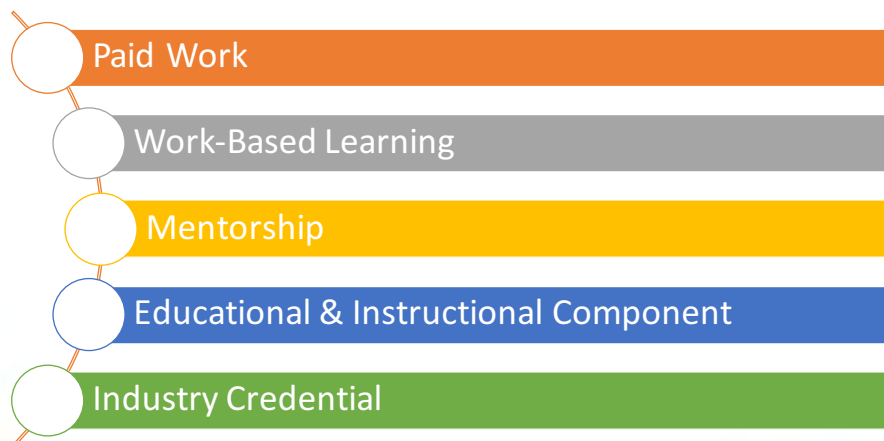
A customizable model of apprenticeship that has been validated by a proven industry accreditor.
